- 2. Clients must be over 18 years old to participate in the trip.

- 4. The company agrees that if unforeseen circumstances arise, other than stress of weather, to prevent the voyage taking place, a full refund will be made.
- 5. The company reserves the right to make alteration to the agreed sailing programme where necessary but will inform the client of any relevant changes.
- 6. The company reserves the right to exclude any person considered unsuitable without explanation.
- 7. Everyone aboard agrees to sail under the command of the yacht's Skipper and abide by his or her decisions and carry out duties assigned.
- 8. Sparkling Spirit is insured for legal liabilities whilst the client is onboard. However, this does not cover travel to and from the boat and the company cannot take responsibility for personal valuables or for any illness, injury or accident sustained through no fault of the company, or while the client is ashore. The client is advised to take out their own travel insurance for the trip, ensuring their policy covers sailing, cruising and yachting and cancellation insurance, including if they have to cancel due to illness. The company would also advise appropriate health insurance for the client's own country.
- 9. No livestock or pets may be brought aboard the vessel.
- 10. No illegal drugs may be brought or consumed on board the vessel.
- 11. Alcohol may be brought aboard and consumed in moderation, only at the Skipper's discretion.
- 12. Smoking, vaping of the use of other smoking devices is not permitted at any time inside the cabins or saloon. Smoking on deck is permissible at the Skipper's discretion.
- 13. Client to pay a 25% deposit to secure booking, and full trip balance at least **30 days** before commencement of trip.
